# **QSR** synthesis report

A synthesis report of all thematic QSRs is planned for 2025, thereby assessing the current environmental state of the Wadden Sea focusing on habitats and species, the linkages between these and current pressures upon them. The drafting of the report shall be performed in connection to the joint Strategical Environmental Assessment (SEA) requested by the World Heritage Committee.

### **QSR** process review

A QSR process review and proposal for the future organization and set-up of the QSR process is planned, to be presented for the WSB 45 in spring 2025. This should include organizational aspects as well as proposals on finances, content, responsibilities, authorships and review process and shall be prepared under consultation of relevant trilateral bodies and external partners.
